The tenders will be opened on the same day in the presence of the bidders/ representatives , after completion of Auction as per the (2) below
2. There will be an auction to be conducted at 2.00 P.M. on the same day.

3. The amount that can be offered for the vehicle shall be furnished in the prescribed format. EMD of Rs.5,000 /- either in cash or DD is required to be furnished along with the Rate offer in the prescribed Format. Bidders paying EMD in cash is required to remit the amount at the cash counter of the company and enclose the original cash receipt with offer. In case of DD the same should be enclosed with offers. The prescribed format can be downloaded from the Corporation's Website ([www. bevco.in](http://www.bevco.in)) or can be obtained from KSBC Head Office.
4. If the bidder intending to participate in the Auction / Bidding for both the Cars shall submit separate offers. The Auction will also be conducted separately for each car.
